Pre-entries must be received by August 17th, 2011. No telephone, e-mail, or fax entries will be accepted. **Checks must be payable to TCKC.** There will be no refunds for absent entries. Refunds will be made for withdrawn entries only if request is made prior to closing date. Refunds will be made if the trials must be cancelled by the host organization.

Show site will open at 7:00 am. Gate entries & check in begins at 7:30 am. Walk-thru & judge's briefing for Trial 1 Novice will begin at 8:45 am. Judging begins promptly at 9:00 am.

Facility

Our facility is climate controlled and the floor matting is 1/2" anti-fatigue rubber matting. There is ample crating space inside and plenty of parking. We have a nice grassy area to walk and potty your dog. Please remember to pick up after your dog. There will be a practice area inside with a jump for practice with your dog.

Food and Beverages

A continental breakfast will be provided. Lunch will be available on site for \$6.00. There are also several fast food restaurants within a few miles of TCKC. Please bring drinking water for your dog and yourself.

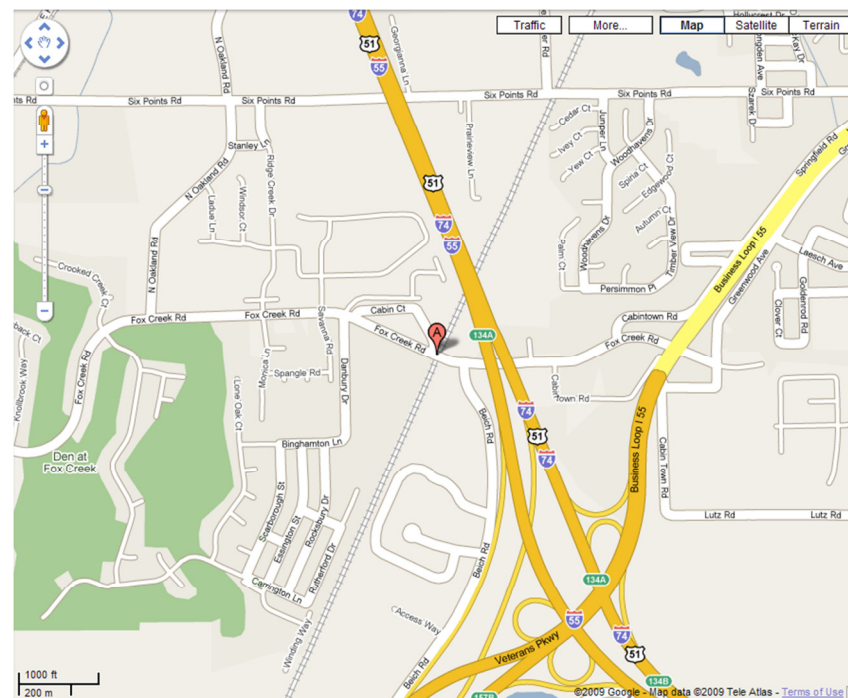
Awards

A qualifying ribbon will be awarded to each team who earns a score of 170 or higher. Placement ribbons will be given to the 4 top scoring teams in each class.

First Place Blue Rosette
Second Place Red Rosette
Third Place Yellow Rosette
Fourth Place White Rosette

Rosettes will also be awarded for High in Trial, High Combined and new Titles. Bonus points earned are not applied to scores considered for High in Trial.

Directions:

From the North: I-55 to Bloomington. Follow signs for Rt. 51 South to Decatur and I-74 towards Champaign. Exit at Veterans Parkway North. Stay in the left lane and exit Veteran's Parkway at Fox Creek Road. Turn left on to Fox Creek Road. Go 8/10 of a mile to TCKC, a large beige and brown steel building on the right

Notice to Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of CDSP Competition Obedience rules and regulations including but not limited to the following rules regarding entry:

- This trial is open to all dogs being at least six months of age, including purebred and non-purebred, except bitches in season or dogs with disabilities, injuries or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans.
- All dogs must be registered with CDSP obedience to compete.
- Dogs must be shown by a member of the owner's immediate family: mother, father, spouse, life partner, sibling, child, grandparent, or grandchild.
- Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- The organizing committee may refuse any entry for any reason.

In addition,

• THERE SHALL BE NO REFUND for entries withdrawn or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.

• Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark of notice of returned check here notification is received after event date. Any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification, or the dog's registration may be suspended pending restitution. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is canceled without recourse by owner/handler.

• No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the organizers.

• All dogs shall be shown in a flat buckle or snap collar, or properly fitted martingale (limited slip) collar. No choke collar, prong collars, shock collars, harnesses, martingale leads, or head collars are allowed.

• All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. Owners with disabilities are encouraged to compete.

Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.

• Exhibitors that plan to use food as a reward in the ring must indicate that on their entry forms. All teams NOT using food shall be scheduled to compete before those teams using food.

• Dogs must be on leash while on show grounds

• Please pick up after your dog and yourself
